The impact of Covid-19

Along with everyone else, Emmaus Merseyside has had its share of challenges presented by the Covid-19 pandemic. This has affected both our residential community and social enterprise activities.



Community life

So far as life in Seaforth Green House is concerned, we started the year with a renewed commitment to reaching full capacity as soon as possible. However, the onset of the pandemic soon reduced the number of companion applications. We were however pleased to able to work with Sefton Council to accommodate a number of homeless people as part of the "Everyone in" initiative. Although not strictly Emmaus companions, this was a good example of partnership working involving the Bosco Society and our local authority.

Whilst the pandemic clearly involved significant changes to normal working practices and meant that some companions had to self-isolate for precautionary reasons, we have been fortunate that, to date, no one has tested positive. During the period when the shops were required to close, companions were able to catch up with many tasks that needed attention and keep busy at our community home and gardens.

Social enterprise

Our social enterprise activities have been severely affected this year. We had to close the Sandy Road Charity Superstore in March and the two Charity Re-Use Shops located on the Household Waste Recycling Centres at Irlam Road in Bootle and Cheadle Avenue in Old Swan Liverpool were also closed. After undertaking detailed risk assessments and putting in place the necessary protective measures, we were ready to re-open our Superstore when the first period of lock down was lifted on 15 June. It was encouraging to see so many regular customers and supporters returning to the store, as well as being able to welcome some new faces. Our Charity Superstore was doing well until the second lock down across the Liverpool City Region caused a further period of closure on 5 November. We're happy to have reopened at the start of December.

The Charity Re-Use Shops have not fared as well. Unfortunately the layout and site facilities at Irlam Road Household Waste Recycling Centre do not offer ready access to the Re-Use Shop. This, combined with the general restrictions placed on all customers wishing to visit the site, meant that footfall has been much lower than usual.

The Cheadle Avenue Recycling Centre has an excellent catchment area, and the Re-Use Shop has better accessibility. Trading activity there was picking up nicely after the first lock down, but a small fire broke out in the shop just prior to the the second lock down. Investigations into the cause are continuing. We are hoping that when circumstances allow, we can have further discussions with Veolia to create more space at the Cheadle Avenue Re-Use Shop to enable us to take in larger items of furniture and other household goods. This would greatly improve the trading activity and reduce the amount of goods sent to landfill. A benefit for both Emmaus Merseyside and the environment.









In order to utilise all the resources which are available to Emmaus Merseyside, we have been working to develop the external space around our residential accommodation in School Lane. To date we have eradicated the contamination of the whole site area (due to remains of war damage) and begun the erection of polytunnels and raised beds to propagate from seed and grow-on seedlings.

Further capital funds are required to complete the physical works to utilise the whole site. We are also looking for funding to employ a Horticulture Manager to oversee the development and management of the initiative together with some operating costs. The work which has been done on the project plan to date indicates that the site could produce fresh food to supplement the requirements of the kitchen at Seaforth Green House together with a weekly local fresh food stall. Planters, window boxes and hanging baskets could be made and sold locally and there is potential to supply other local markets with bedding plants. Honey and other niche products could also be produced. A training facility would be incorporated in the project to enable companions and other volunteers to acquire the skills and expertise necessary.

We are about to start on what we hope will be the final stage of our fundraising activity to enable us to implement the exciting plans for this project as soon as possible. If you would like to get involved or partner with us for this exciting development, please do get in touch.
